3. Budgetary for 2015 Ford purchase – Discussion on purchase of 2015 Ford on November 2, 2022 and what line items to take the cost from. Line items 17 & 18 for a total of \$10,347 which will purchase vehicle (\$8,500) and have money to change lens lights and additional for any vehicle maintenance. Durepo made a motion to use line items 17 & 18, 2<sup>nd</sup> Brooker. Discussion - Philbrick is not comfortable with vote as the car should have been on the agenda. He was reminded tonight's vote is to find in the budget the money to purchase, not whether to purchase. Elliott states the truck will be retired once we have the car because the under carriage is almost gone. No further discussion. So voted Three in favor, one opposed. Pelletier had to leave at 7:24pm and was not part of this discussion or vote.

4. Highway Dept - There is a need for an operator position in the highway department to be filled as soon as possible. There are two people on staff and one person that helps during snowstorms. Durepo states advertising presence is weak/limited and we are missing the boat on how we advertise. Elliott states it has been advertised on town website, Facebook and local newspaper. Discussion continued on wages and whether Limestone is competitive for same positions being advertised. Motion made by Brooker to give Elliott authority to negotiate up to \$3 more an hour to hire for the highway department, 2<sup>nd</sup> Pelletier. So voted.




5. Adjourned – 8:02pm Motion made by Durepo to adjourn, 2<sup>nd</sup> by Philbrick.
