In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Limestone, in said county and state, qualified by law to vote in Town Affairs, to meet at the MSSM/LIMESTONE COMMUNITY SCHOOL GYMNASIUM in said Town, on TUESDAY the FOURTEENTH (14th) day of JUNE 2023 at EIGHT O'CLOCK IN THE MORNING (8:00 A.M.) then and there to act by written ballot upon Article 1 and by secret ballot upon Article 2 as set out below, the polling hours thereof to be from EIGHT O'CLOCK IN THE MORNING (8:00 A.M.) until EIGHT O'CLOCK IN THE EVENING (8:00 P.M.);

ARTICLE 1 To elect *by majority on written ballot*, according to the provisions of the Revised Statutes of Maine, Title 30-A, Section 2524: a moderator to preside at said meeting.

MOTION BY Gail Caldwell to nominate Alan D. Mulherin for the moderator. SECOND by Doreen Beaulieu

ARTICLE 2 To elect *by majority on secret ballot*, according to the provisions of the Revised Statutes of Maine, Title 30-A, Section 2528: One (1) Selectperson, who shall also serve as Assessor to serve for a term of three (3) years; Two (2) School Committee Members for terms of three (3) years; and One (1) member of the Limestone Water & Sewer Board for a term of three (3) years.

And at eight o'clock (8:00 p.m.) the polls shall close for the election of officers for 2023 and the meeting will be adjourned until WEDNESDAY THE FOURTEENTH (14th) day of JUNE 2023 and will reconvene at the MSSM/LIMESTONE COMMUNITY SCHOOL AUDITORIUM in said Town at SIX THIRTY IN EVENING (6:30 PM) to act upon the remaining articles set out below to wit, and IF NEEDED, ON THURSDAY the FIFTEENTH (15th) day of JUNE 2023 at SIX THIRTY IN THE EVENING (6:30 P.M.) when the meeting will reconvene at the MSSM/LIMESTONE COMMUNITY SCHOOL AUDITORIUM in said Town to act upon the remaining articles set out below to wit:
