We encourage you to use the next few weeks to make plans for the remaining balance on your site. Final payment is due no later than **Friday, May 19, 2017.**

If your completed paperwork and your deposit are not received at the Town Office by Friday, April 28, 2017 and your final payment is not received at the Town Office by Friday, May 19, 2017, your seasonal site is not guaranteed.

After that date, all sites are on a “First Come, First Serve” basis.

Season – The campground will open Memorial Day Weekend and will close the weekend following Labor Day (weather permitting).

RV RATES – We have **34 RV** sites with Full Hook Up:

1. Seasonal campers, a deposit of **\$125.00** must be made by **April 28, 2017** in order to reserve your site.
2. For short term reservations, a deposit of half of the lot price for the term of the reservation must be made to reserve site.
3. Sites will NOT be held unless deposit is made.
4. Seasonal lot rents must be paid in full by **May 19, 2017**.

REFUNDS – Initial deposits will be refunded, less a \$10.00 handling fee, providing notice is given at least 30 days prior to scheduled arrival date.

1. Any notice after 30 days or failure to arrive on scheduled date will result in NO REFUND.
2. No refunds will be issued for early departure or late entry.
